Santa Margarita Groundwater Agency, a groundwater sustainability agency, is hosting a community meeting on 01/12/19 to engage and inform all people who rely on the water supply from the Santa Margarita Groundwater Basin. The Santa Margarita Groundwater Basin is the major water source for communities in the San Lorenzo Valley, Scotts Valley, the City of Santa Cruz and unincorporated areas of Santa Cruz County.

This community meeting, “Land Use and Water: How Much Does Growth Matter?” will provide information on land use planning and how it relates to the water supply and will include a keynote speaker; break-out sessions where participants can engage with each other, water management staff and elected leaders; informational displays; and an expert panel discussion.

The Scotts Valley Water District Board of Directors will not take any action.
