Rebate Application – Greywater Irrigation: Rules & Requirements

1. These rebates require a pre-inspection by District staff. **Do not start work until after the pre-inspection.** A representative of the District must be permitted to inspect the property to verify installation and presence of relevant fixtures/features. To schedule an inspection, submit a signed copy of this form and call (831) 438-2363 or email conservation@svwd.org. The account holder or authorized representative must be present during all inspections. **Failure to schedule a pre-inspection will result in the application being denied as incomplete.**
2. A post-inspection verifying replacement of relevant fixture/features **must be completed within 180 days of pre-inspection for approval.** A representative of the District must be permitted to inspect the property to verify completion of work. To schedule an inspection, please call (831) 438-2363 or email coservation@svwd.org. The account holder or authorized representative must be present during all inspections.
3. **It is the applicant's responsibility to review and comply with applicable state and local laws and regulations** (i.e. from the County of Santa Cruz or City of Scotts Valley) pertaining to greywater systems.
4. Applicant must install a greywater system to irrigate landscapes.
5. Qualifying sources of greywater are washing machines, showers, or bathtubs. **Greywater should not be stored.**
6. If approved, applicant agrees that all fixtures/features will remain in place for five (5) years.
7. The equipment must be installed in an existing SVWD service address. New development is not eligible for rebates.
8. Rebates will be issued in the form of a mailed check unless a request is made for account credit. Please allow four (4) weeks from the date of approval for processing.
9. The account must be in good financial standing for program eligibility.
10. Installation of any device, appliance or fixture is the sole responsibility of the applicant, as is determination of the adequacy and compatibility of the existing plumbing system.
11. The District does not endorse specific brands, products or dealers; nor does it guarantee materials or workmanship; acceptance of such is customer's responsibility.
12. The District assumes no responsibility or liability for any damage that may occur to an applicant's property as a result of participation in the program. The District cannot guarantee that installation of rebated fixtures or measures will result in lower utility costs.
13. All installations must follow the California Universal Plumbing Code. For information on California building codes please visit <https://www.library.ca.gov/law/building-standards/>.
14. The applicant is solely responsible for the proper disposal of all materials associated with the installation of credited fixtures and equipment and SVWD assumes no responsibility or liability. Please recycle materials.
15. All communications regarding the rebate process will occur via email. If you do not receive a copy of this form via email within 7 business days of submission, please contact the District Conservation Department at 831-428-2363.
16. The District may at any time modify this program without prior written notice. Prior versions of this form are obsolete and will not be accepted.
17. Incomplete or illegible applications will be denied.
